# Birthday Party Agreement

Your date will be confirmed upon receipt of this contract with a \$50.00 non-refundable deposit (cash or check only) on a first-come basis. **A final Guest List of attendees will be due 24 hours prior to event date/time & should include those unsure of attending.** Failure to pay the deposit and failure to submit final number and Guest List will result in forfeiture of date. Final balance, payable in cash or check only, including adjustments is due at the scheduled conclusion of the event. You will not be charged for guests that do not attend unless your actual number of children falls below the minimum number of 13, in which you will be assessed the minimum flat fee. There is no minimum number for Do It Yourself parties, however there is a \$25 per hour rental fee (\$50.00 non-refundable deposit) for the use of the tent in addition to the admission charge, with a minimum rental of 4 hours. **VALLEYBROOK COUNTRY CLUB DOES NOT ACCEPT ANY FOOD DELIVERIES AND CAN NOT STORE ANY FOOD, CAKE OR ICE CREAM.**

Valleybrook Country Club (herein also referred to as VCC) shall not be liable to the lessee for any loss or damage to the lessee or to any other person or to the property of the lessee or of any other person unless such loss or damage shall be caused by or result from a negligent act of omission or commission on the part of VCC, or any of its agents, or employees. The said lessee shall indemnify and save harmless VCC, its successors or assigns, from all claims and demands of every kind that may be brought against it, them or any of them for or on account of any damage, loss, or injury to persons or property in or about the leased premises during the term of the lease, and from any and all costs and expenses, including court costs and attorneys' fees and other charges which may be imposed upon VCC, its successors or assigns or which it or they may be obligated to incur in consequence thereof.

- (A) Renting party agrees to make all attendees aware of, and comply with all posted and printed rules of VCC. A list of the rules has been enclosed with his contract.
- (B) VCC is fully licensed for the sale of all alcoholic beverages. It is illegal for anyone to bring alcoholic beverages of any kind onto the property.
- (C) It is the renting party's responsibility to see that absolutely no minors are allowed to consume any alcoholic beverages on this property. If anyone is found to be violating this law, they will be expelled from this property immediately and reported to the police.
- (D) Renting party is requested to perform reasonable basic clean-up after the event (i.e. disposing of refuse in containers provided).
- (E) **Guest lists are required for all groups & MUST be submitted 24 hours prior to the event. They should include anyone who MIGHT attend.**
- (F) Rowdiness, loudness, profanity, drunkenness, etc. will not be tolerated.
- (G) All vehicles entering and leaving the premises must do so at 10 miles per hour or less and by standards of the Maryland State Department of Transportation.
- (H) In the event of theft of any club property, the lessee agrees to pay the cost of repair or equal replacement.
- (I) VCC reserves the right to determine the number of persons attending the event.
- (J) Pools close at 8:00 pm and guests are requested to leave party/picnic areas at conclusion of party (most birthday parties run from 2:00 pm to 4:00 pm).
- (K) No drugs, narcotics, or controlled substances of any kind are allowed on the club property at any time.
- (L) Guests are required to wear attractive leisure sportswear to the club. Swimsuits must be worn in the pools at all times (shorts and/or cut-offs may not be worn in the pools). Proper tennis shoes and clothing must be worn on the tennis courts at all times. Shirts are required on the tennis courts at all times.
- (M) **CANCELLATION POLICY:** Cancellations due to weather conditions must be made 30 hours prior to scheduled start time. All groups forfeit their deposit (\$50.00) if the event is canceled, for any reason, before the event date.
- (N) The balance will be due immediately upon conclusion of the event, payable by cash or check, including adjustments for any damages that may have occurred and/or borrowed equipment not returned.

## POOL RULES

1. No running.
2. No diving from the pool side. Diving is only permitted from the diving boards.
3. Rowdiness, shoving, spitting, spouting, nose-blowing, etc., is strictly prohibited.
4. No riding on others' shoulders.
5. No touching or hanging on the ropes.
6. No hard toys (including diving sticks and water guns).
7. No balls (this includes beach balls and splash balls).
8. Non-swimmers must wear life preservers even when accompanied by their parents.
9. Non-swimmers are NOT allowed in the deep end of the family pool or in the diving pool.
10. No floaties, noodles, or life preservers of any kind are permitted in the deep end.
11. In order to use the slide, swimmers must be able to slide and *swim to the ladder unassisted*.
12. Swimmers must go feet first in a sitting position when using the slide.
13. When using the slide or diving boards, swimmers must exit the pools using the ladders.
14. Those waiting to use the slide or diving boards must wait on the ground, at the base of the slide or board, until the previous swimmer has reached the ladder.
15. When using the diving boards, one bounce only.
16. No cartwheels or in-ward dives allowed on the diving boards.
17. No food of any type permitted in the pool areas, with the exception of the adult pool .
18. Clean bathing suits only may be worn in the pools. Shorts and cut-offs will not be permitted in the pools.
19. Children not toilet-trained must wear swim diapers or very tight fitting diapers with plastic or rubber pants.
20. Band-aids and bandages must be removed before entering the pools.
21. No glass containers of any kind may be brought onto the club property.
22. No skateboards, scooters, or rollerblades allowed.
23. Absolutely no fishing, swimming, or wading in the pond.
24. No smoking permitted in the pool areas.
